The regular meeting of the Upshur County Emergency Services District No. 1 Board of Directors was held on December 14, 2020, at the Gilmer Civic Center, Hwy. 271 North, Gilmer, Texas.

- 1) Open meeting. The meeting was opened by Gaston DeBerry, III at 7:03 p.m.
- 2) <u>Call to order</u>. Gaston DeBerry, III called the meeting to order.
- **3)** <u>Determine quorum present</u>. Gaston DeBerry, III determined a quorum was present with Shelby Henderson and Ricky Evans, Jr. being absent.
- 4) Read and approve the minutes from the Regular meeting held November 9, 2020. Motion was made by David Tackett and second by Marc Nichols to approve the minutes from the Regular meeting held November 9, 2020. Motion carried 3-0. Unanimous vote in favor.
- **5)** Public Comment. Gilmer Fire Chief Jerry Taylor discussed SCBA Air Compressor Service for Gilmer and Ore City. Glenwood Chief Mike Fennell discussed sending those interested to Fire Academy.
- 6) <u>Discuss and take action regarding the Siddons-Martin bill for Bettie V.F.D.</u> Motion by Marc Nichols and second by David Tackett to pay the bill in the amount of \$11,453.65 for Bettie VFD out of retained earnings. Motion carried 3-0. Unanimous vote in favor.
