- 2) <u>Call to order</u>. Gaston DeBerry, III called the meeting to order.
- 3) Recognition of new commissioners of the Upshur County Emergency Services District No.

 1 appointed by the Upshur County Commissioners Court. Gaston DeBerry, Ill introduced Gary Smith and Michael Kuza as the new commissioners appointed by the Upshur County Commissioners Court and announced the resignation of Shelby Henderson.
